"New trends on Adult Education"

Tuesday - 16 November, 2010

Summary results of the inquiry completed by participants at the conference "*New Trends on Adult Education*", held in the European Parliament, Brussels on 16 November 2010.

The idea of inserting three multiple-choice questions on the conference registration form, had the objective of guiding the discussion among participants. We received 232 requests (from 25 countries) to attend to the conference, and 179 aplicants responded to the questinonaire. The list of respondents is presented in Annex 1 and full results presented in Annex 2. The conference's primary aims were to contribute to the new generation of learning strategies and the debate allowed conclusions accordingly. However, considering the number and profile of respondents, some extra outcomes, emerged from the analysis to the questionnaire.

The primary objectives of Education and Training Programmes

A key-objective of the Strategic framework for European cooperation in education and training (ET 2020)², is to promote "<u>equity, social cohesion and active citizenship</u> – education and training should enable all citizens to acquire and <u>develop skills and competencies needed for their employability</u> and <u>foster further learning</u>, <u>active citizenship and intercultural dialogue."</u>

In line with these objectives, 99% of respondents to the questionnaire, think that the promotion of equity, social cohesion and active citizenship, should be the main objective of Education and Training Programmes. This was the most consensual question of all inquiry: only 1% disagrees and 61% strongly agree.

However, the answers to the question "Education and training Programmes, should be focused on improving **professional competencies**, of mature and older adults?" were not consensual: 16% of respondents disagree and 29% strongly agree.

The need to improve "**Linguistic competencies**" was also not highly consensual: 15% of respondentes, disagree that mature and older adults should improve these competencies, and only 24% strongly agree with this option. Respondents strongly agree that those mature and older adults should improve their **Intercultural competencies** (43%) and "**learning to learn" competencies** (45%). Only 7% respondents disagree with these options.

New and improved strategies to deliver education and training

The ET 2020, it's also about to find "more flexible learning pathways" and to make education and training "more attractive and efficient".

47% of respondents strongly agree that next generation of Education and training Programmes, for mature and older adults, should pay more attention to **Intergenerational Learning**. Only 5%, diagree with this option. A very similar percentadge of respondents strongly agree that special attention should also be paid to **Mentoring and Befriending** (32%); **Self-directed Learning** (31%) and **Community based learning** (31%).

Because the questionaire had some open questions to allow the inclusion of itens – e-learning and other forms of cooperative online learning and "virtual education", have been the suggestion most mentioned by respondents. A large number of respondents also mention competencies to improve: health and wellbeing, artistic skills, self-trust and self-confidence, adaptability and active ageing.
